### 7pm Open Forum -

Attended by Trevor Thwaites and Richard Tout. Both were concerned about the closure of Northcote Wharf and the exorbitant spending on the Queen Street section of the Northcote Safe Cycle Path.

4. Minutes of the Executive Meeting 8 May were **CONFIRMED**
5. Matters arising  
Pedestrian crossing- submission had been made, approving the design of the Rodney/Queen crossing, but reminding AT of their officers' previous agreement to provide a crossing also at Vincent/Queen and asking when it would be put in place  
Rules review – brief discussion – against restricting area; against Associate membership  
Tidal flooding - KLB report still to come.  
Fencing Stokes Pt. – no response to letter.  
Bartley Street toilets – would need concerted effort to reverse KLB decision to remove.  
Anne had advised new MP Dan Bidois of this situation and of the wharf closure.
6. Election of Chair, Secretary, Treasurer – deferred until all are present.

  - b. Send letter commending John Gillon action in cutting out free lunches for KLB
  - c. Anne had noted a workers' bus going from Stafford through LSB at about 5pm.
